ICD-10 Transition

As required by the federal government, the ICD-9 codes currently used on claims to identify diagnoses and inpatient procedures are being replaced by ICD-10 codes effective October 1, 2015. ICD-10 codes must be used for dates of service and dates of discharge on or after October 1, 2015. ICD-9 codes will continue to be required for dates of service and dates of discharge on or before September 30, 2015, regardless of when the claim is submitted.

This webpage will be updated periodically with resources to assist providers in their transition to ICD-10, including helpful links, online training modules covering billing and testing requirements for New Hampshire Medicaid, and other important information.
